The Community Information Meeting is set for April 7,

with doors opening at 6:00 pm and the presentation at 7:00 pm.

The Denman Island Local Trust Committee schedules a Community Information Meeting for April 7 to review draft bylaws for Riparian Areas Regulation, with doors opening at 6:00 pm and the presentation at 7:00 pm.¹

The committee directs staff to schedule the meeting in March or early April so the community can review the draft bylaws.¹

Planner Rob Milne presents referral responses and outlines changes suggested by the Ministry of Forests, Lands and Natural Resource Operations. Trustees discuss the changes and possible effects on timelines and costs.¹

The committee decides to present the draft bylaws in their current form, including the suggested changes, to inform the community and gather

feedback. Trustee Laura Busheikin offers to book the venue.¹
