A community information meeting and public hearing are scheduled for Bylaws

219 and 220 in the afternoon of June 25.

The Denman Island Local Trust Committee schedules a Community Information Meeting and a Public Hearing on Bylaws 219 and 220 for June 25, 2016, with the information meeting preceding the hearing.¹

The bylaws concern proposed amendments to the Denman Island Official Community Plan and Land Use Bylaw.¹

The committee discusses a proposal to prohibit secondary

cottages on the receiving property, and invites the applicant to speak about that approach.¹

The committee also adopts Bylaws 212 and 213 concerning riparian areas regulation amendments to the Official Community Plan and Land Use Bylaw.¹

The next regular meeting is scheduled for July 5, 2016, at 10:30 am at the Denman Seniors Centre.¹
